Buyer may declaw this kitten, but agrees that declawing the cat/kitten will void any and all guarantees listed within this contract.

responsible for any charges incurred in the time of absence of the kitten from the Seller's residence. After 24 hours the purchaser is responsible for all health and behavioral needs and costs and the Seller will not accept the kitten back for any reason and will not issue any refunds. Buyer understands that seller is not liable for diseases, viruses, or any other condition the cat/kitten may contract without proper vaccination. Buyer agrees to maintain cat/kitten's health and wellness with proper and timely veterinary visits and obtain any recommended vaccines/treatment by the healthcare provider.

- 8) Buyer understands that this kitten **IS** spayed or neutered (unless it is for breeding purposes). Buyer agrees to pay Seller the cost of the surgical procedure upon pick-up, delivery.
- 9) Buyer understands that this kitten has had its initial vaccinations: Merial Purevax FVRCP which is used to prevent Panieukopenia, Rhiontracheitis and Calicivirus. Kitten is vaccinated at 8 weeks of age and 12 weeks of age. (see vaccine record)
- 10) **Shipping** Buyer understands that shipping (flying or ground transportation) can be stressful on their new kitten. This stress can sometimes weaken the kittens immune system and therefore kitten may get a respiratory infection. Buyer agrees that if kitten shows any signs of respiratory issues (sneezing, stuffy nose, watery eyes) he/she will seek medical treatment at buyers own expense.

FEEDING & LITTERBOX INSTRUCTIONS

<u>Feeding Instructions</u> – Your kitten is used to the following food and is recommended for the overall health of your kitten as well as its coat. A quick change to a cat/kitten's diet can result in severe intestinal upset. Note: Any food changes should be made gradually. Seller does not recommend a diet change. **Not Eating:** It is perfectly normal for a new kitten to be slightly off its feeding schedule for a few days. Just give your kitten plenty *of* love and attention while it is adapting to is new environment, and it will resume eating. If your kitten does not eat at all, you should encourage it by feeding it canned food from your fingers.
